METHOD

RESULTS AND DISCUSSION

in various parts of the world via the internet. The industrial revolution 4.0 has basic principles,

The industrial revolution 4.0 digitalization era has four designs⁵. First, interconnection,

Third, technical assistance in the form of the ability of digital systems to support humans in solving problems in a short time. Fourth, decentralized decisions, namely the ability of the system to make its own decisions and work effectively.

In short, the digital era is an era where humans not only work together with other humans but also collaborate with sophisticated machines to speed up work. The digital era is marked by the existence of internet networks, virtual information systems, and artificial intelligence. The era where the world is without physical boundaries in terms of knowledge and information. Degradation is defined as a decrease, weakening, erosion, or changes approaching damage⁶. Meanwhile, morals are defined as education in ethics, manners, and morals about how to do good and respond to the environment properly. So, moral degradation is a phenomenon of a decline in awareness to behave according to norms, good ethics, and morality. Moral degradation occurs simultaneously with the fading of legal values in the human heart. Along with the development of civilization, the world moves through significant changes every time.

The industrial revolution 4.0, which carries the spirit of digitalization and automation, has brought major changes to the order of life in the global community. The internet can be said to be the main pillar of human activity in various fields. Everything that comes always brings two undeniable sides of the coin. It is undeniable that moral degradation also originates from technological sophistication, which is becoming more and more common day by day. Openness of the world that is not able to respond properly brings destructive currents. According to Lickona, moral degradation is characterized by several phenomena such as increased crime, the use of words

Moral degradation needs to be looked at intensively considering that its existence is so basic in the order of life of the nation and state. In the past, students always followed the teacher's good orders, spoke politely, and paid respect. Nowadays, it is not uncommon for television shows to present students mistreating their teachers, beating up teachers, or killing their peers because of unhealthy competition. Schools do have an important role in fixing the morality of the nation's generation. However, the orientation of education which is based on sheets of paper filled with numbers obscures the true purpose of education. Whereas the Constitution of the Republic of Indonesia states that the purpose of education is to produce human beings with noble character followed by descriptions of creative, intelligent, independent human beings and other competencies⁸.

Thus, character or morality is not well formed because it only stops at the stage of moral knowledge. Ethics is only studied textually in books and then memorized with the aim of getting good grades on exams. Individuals do not live up to the moral and apply it in action⁹. In fact, the essence of moral education is in its application. How to behave, be responsive and responsive to the environment with good ethics and morals.

The Threat of Adolescent Moral Degradation in the Digital Age

The development of technology has an impact on a person's moral decline, especially for teenagers because they are vulnerable to being affected by changing times. This can be observed in the surrounding environment, such as the number of rampant violations and crimes such as harsh speech, the fading of politeness towards elders, theft, pornography, and online fraud. If left

unchecked it can damage the nation¹⁰. Moral degradation can be influenced by various factors, but the most prominent factor is the impact of globalization which has resulted in changes in the order of people's lives. Currently, various phenomena show that teenagers are experiencing a moral decline, this is the result of a deviant style on social media, then they imitate it. With the development of technology, it can indeed make it easier for someone in their life, but if they are not wise in using it, it will have a bad impact on them¹¹.

Global Factors in Adolescent Moral Degradation

There are some global factors in adolescent moral degradation, including:

- a. Someone considers the yardstick of success only in material terms and ignores morality.
- b. The inclusion of Western culture which is easily accessible in ICT makes decency morals decline.
- c. The higher the competition due to open local partitions.
- d. People's individuality is getting higher and there is a lack of concern for the environment, resulting in low moral control among adolescents.
- e. Lack of direction from the family, because each parent has their own activities and even a broken home.
- f. lack of emphasis on the importance of morality when in school due to limited time, resources, and funding sources.

Then, this was concluded by Kartini Kartono that the moral degradation of adolescents results from bad environmental influences, weakening of self-control and social control.¹²

Forms of Adolescent Moral Degradation

In terms of its type, there are four kinds of moral degradation, namely:

- a. Individual, included in delinquency that is done individually and leads to crime. The cause of this is the tendency to behave deviantly because of the supportive social and cultural conditions.
- b. Situational, namely normal children commit delinquency because of the influence of the situation, social and pressure from the environment that seems to force.
- c. Systematic, acts of delinquency that have been arranged systematically in an organization in the form of a 'gang'. A collection of behaviors that have rules, roles, formal status, distinctive language, and even pride.
- d. Cumulative, an acquaintance that is carried out continuously, various places imitate this acquaintance so that it can cause social disintegration. Cumulative can be done by individuals or groups. If someone has reached the level of accumulation, it is very difficult to restore his behavior according to the prevailing norms¹³.

Meanwhile, when viewed in terms of shape, there are various forms of degradation as follows:

- a. A delinquency that can cause physical injury such as: robbery, murder, rape, and fighting.
- b. A delinquency related to material such as: extortion, pickpocketing, and theft.
- c. A delinquency that does not affect other people such as: drug use and prostitution.
- d. An acquaintance with refusing status such as: refusing the status that he is a student is by skipping school.
- e. A non-criminal delinquency, where a person prefers to be alone than to participate in activities that involve many people. People like this are usually irritable, easily panicked, confused. Then, they took it out by getting drunk, taking drugs, and even committing suicide.

Effect of Cybercrime in Adolescent Moral Degradation

Cybercrime is a crime motivated by the use of information technology. The breadth of internet reach also expands human behavior in using it. Convenience is often a source for venting wild imaginations that lead to negative things. According to Hius, Jummaidi & Anhar in the 2014

National Seminar Proceedings, cybercrime is divided into several categories ¹⁴. First, pure cybercrime, namely the deliberate destruction of computer information systems.

Second, cybercrimewhose motive for the crime is not clear. The perpetrator only broke into the information system without destroying it. Third, cybercrime that specifically attacks a person personally, such as pornography and cyberstalking. Third, cybercrime that attacks a person's ownership rights regarding works, such as illegal copying of book soft files, plagiarism, and the like. Finally, cybercrime that attacks the government. The action was carried out by destroying the state information system with the aim of disrupting the state government system.

Today's life cannot be separated from the pursuit of the internet. The release of data from the Central Bureau of Statistics in 2013 predicts the number of Indonesian millennials in 2015 will be 33% and will continue to increase¹⁵. That means around 85 million Indonesian people are people whose lives cannot be separated from the internet whether for educational activities, business, or just to connect with friends. The education sector does not seem to be directly affected, but if you dive deeper it plays an important role in building the character of students. The government has been promoting character education lately as a response to field conditions where students are increasingly distant from eastern cultural values.

Cybercrime make internet circulation mixed without filter¹⁶. Meanwhile internet consumers come from various groups with their respective readiness. Parents are busy working and children are given gadgets so they don't disturb them. Children are not wise in choosing shows so whatever they see is as long as it is interesting. Sometimes I accidentally see shows such as pornography and free sex. When the show is received by minors, it will be fatal. They only understand momentary pleasures without thinking long in making decisions. So it is very prone to fall into promiscuity, meet children who have the same fate and imitate the shows they see.

Not to mention shows that contain elements of violence. Children see without parental assistance and think that fighting is a symbol of valor and courage. Their emotions are not stable and when they are ignited they will reflexively practice what they often see in gadget displays. How many unethical videos to watch and can be accessed freely. Harsh words are consumed casually, heard naturally. Parental awareness is very important to help protect children from cybercrime. Online games are also very likely to be misinterpreted, with the potential for children to become less interactive, difficult to adapt, hard, and have high ambitions but in an inappropriate way.

Students will interact with their friends at school. When there is one child who is lacking in morals, he will become a virus in his environment. Ironically, it seems to be a chain phenomenon. One community will influence each other. Thus, the school environment becomes unhealthy. Education whose goal is to shape the character of students instead becomes a place for students' morals to flee due to things that have gotten out of control. In the end, cybercrime is very influential on moral degradation.

The Influence of Social Media on Adolescent Moral Degradation

Social media is electronic media that can be used easily to replace the role of letters, telegrams, and the like¹⁷. Social media as a symbol of the industrial revolution participates in expanding networks between social circles. The purpose of the crew is indeed to facilitate communication and ease human work. However, individual acceptance varies. Again, accepting change also requires the readiness of human resources. Along with technological sophistication is the misuse of social media.

Research by Ohio State University researchers proves that academically the use of social media has an effect on the growth of student intelligence¹⁸. The time that should have been used a lot to read literature just disappeared because it was too preoccupied with social media. From a moral point of view, the use of social media without control makes it difficult for individuals to

So great is the influence of social media on moral degradation that restrictions are needed, especially for students, teenagers, especially minors. The role of parents, teachers, and the surrounding environment is so big. At an age that is still unstable, they need control from the outside because they still experience a lot of confusion from within.

The Role of Akidah Akhlak on Addressing Adolescent Moral Degradation

The moral creed has a very important role in addressing moral degradation.²⁰Aqidah refers to one's belief and belief in basic values that are believed to be true and cannot be contested. While morals refer to the actions or behavior of a person who is able to reflect good and true values in the life he experiences, namely everyday life.

In addressing moral degradation, moral principles are important because they provide a clear foundation and guide in dealing with complex moral situations.²¹Moral beliefs can provide a correct understanding of one's rights and obligations towards oneself, others, and God. In this case,

Social Environment: A social environment that supports moral and ethical values can be an

important factor in shaping one's character. In an environment like this, individuals will feel more

comfortable and will receive support from their surroundings in practicing good moral and ethical

Factors Inhibiting Faith and Morals in Addressing Moral Degradation:

Media Influence: Irresponsible media can have a negative influence on moral and ethical
